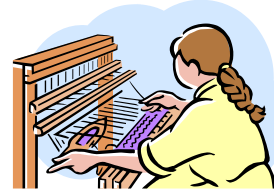


Louisville Art Association Presents: 2024 A Taste of Louisville Festival (Held in conjunction with the city/chamber)



35th Annual Taste of Louisville, Saturday June 1, 2024 – 9:00am to 4:00pm

General Information

The Taste of Louisville Festival is held in Louisville Colorado, conveniently located 7 miles southeast of Boulder and 25 miles northwest of Denver. This historic mining town is famous for its restaurants, and festivals. It is one of the fastest growing cities in Colorado yet retains a charming and quaint downtown area. The festival is a city-wide event and includes great food, live music, farmer's market and family entertainment. The festival advertises widely through the City of Louisville, the Chamber of Commerce, and the Louisville Art Association. Attendance averages 4,000 – 5,000.

Eligibility for this Juried Festival and Rules of Participation

Artists must display works of their own concept and execution. **All work must be produced by the exhibiting artist.** No imports (must be made in USA), kits, resale, pre-fab jewelry or pre-molded ceramics. If your crafts are made by salaried employees or paid piece work, you are **commercial and must apply with the city or the farmer's market.** The work on display in the booth must be consistent with the work presented for approval and will be checked at set-up time.

Sales will be transacted directly between the artist and the buyer. Each artist is responsible for collecting and paying Colorado state tax and Louisville city sales tax. **You Must Have a Tax Number.** You must also obtain a Louisville City Tax License (\$25) in addition to the fee for your booth. No commissions are taken. Booth spaces are **10' X 10'**. You must provide your own tent, display and equipment to fit the booth. **The artist presence at the booth is desirable.** All displays must be free standing, usable on pavement. Weights are highly recommended. The festival is outdoors, so suitable protection from sun, wind, and rain is important. There are no rain dates or refunds. **No pets or alcohol, please.**

How to Apply by Email for this Juried Event

1. Complete the application below and email it to revansjcolorado@gmail.com with your jury info if you have not participated within the last 3 years. Web URL is preferred. Otherwise, 3 close up .jpg photos.
2. You will be notified by email of the jury decision which is final. Jurying is done as applications are received.
3. **Jewelry Vendors:** Please be sure to submit your application early! We have space for only 8 jewelry vendors. The jury will accept the first 8 jewelers that qualify.
4. If you are accepted, mail a check made out to LAA for \$35 (for LAA members) or \$50 (for non-members) to Louisville Art Association PO Box 852 Louisville, **Colorado please write a note on check-- the word Taste**
5. If your check is not received within 2 weeks of email notification (or by the registration deadline if it's earlier), your space will be forfeited, and your check returned to you if it was in transit. **No refunds** after the deadline.
